#### TSL Jewellery Signed HK\$573 Million Commenting on the syndicated loan facility, Development

TSL Jewellery signed a five-year, HK\$573 million syndicated loan facility (the "Facility") agreement with a consortium of four leading international financial institutions. proceeds, which provide a steady liquidity support, will be used as general working capital to cope with the Group's business development.

Representatives from Industrial Bank of Taiwan Co., Ltd - the Facility's mandated lead arranger, facility agent and original lender - and three other participating banks namely Bangkok Bank Public Company Limited, China CITIC Bank International Limited, and The Bank of East Asia, Limited attended the signing ceremony held on September 13, together with Mrs Annie Yau Tse, the Group's Chairman and Chief Executive Officer and Ms Estella Ng, Deputy Chairman, Chief Strategy Officer & Chief Financial Officer.

Syndicated Loan Facility to Fuel Future Mrs Tse said it has a significant meaning to the Group. "It shows that the banking sector is confident towards the Group's solid business fundamentals and its future prospects, while offering a steady liquidity and strong financial capability that can provide substantial support to our future growth. Looking ahead, we will continue to enhance the Group's operational efficiency by grabbing a handful of business opportunities with a prudent yet progressive approach, to create higher value and returns to our customers and shareholders," she mentioned.

> The Facility was guaranteed by the Group's listing arm and entered into by two of its subsidiaries: Tse Sui Luen Jewellery Company Limited and TSL Manufacturing and Distribution Limited. Amounting to HK\$573 million and inclusive of an exercised greenshoe option upsize of HK\$23 million, the Facility has been granted for a term of five years from the date of the first drawdown.

#### TSL Jewellery recognised for its efforts TSL Foundation inspires innovation to Go Green
